Description of the Product

The Nuance Concentrated Value Composite is a classic value investment product investing primarily in the equity or equity-linked securities of United States based companies. The product will typically maintain 15-35 positions in the securities of companies that, in the opinion of the Nuance Investments Team, have leading and sustainable market share positions, above average financial strength, and are trading at prices materially below our internally derived view of intrinsic value. The product's primary benchmark is the Russell 3000 Value Index. Clients may also compare the product to the S&P 500 Index.

Longer Term Performance Update

Since Inception Return: The return since inception on (11/13/2008 through 4/30/2016) is 18.1 percent (annualized and net of fees) versus the Russell 3000 Value Index at 12.7 percent and the S&P 500 Index at 14.0 percent. We are pleased with this level of outperformance over time.

Risk-Adjusted Returns: Our Sharpe Ratio (since inception on 11/13/2008 through 4/30/2016) is 1.3 (net of fees) versus Russell 3000 Value Index at 0.8 and the S&P 500 Index at 1.0.

Peer Group Returns through 3/31/2016: Comparing our product to peers displays positive results over time. On a total return basis, since 11/30/08, we ranked 33 of 1,174 (3rd percentile) peer group members in the Morningstar Large Cap Value universe, 45 of 375 (12th percentile) in the Morningstar Mid-Cap Value universe and in the Lipper Multi-Cap Value universe we ranked 15 of 210 (7th percentile).

Peer Group Risk-Adjusted Return through 3/31/2016: On a risk-adjusted return basis, since 11/30/2008, (measured by the Sharpe Ratio) we ranked 6 of 1,174 (1st percentile) peer group members in the Morningstar Large Cap Value universe, 1 of 375 (1st percentile) in the Morningstar Mid-Cap Value universe and in the Lipper Multi-Cap Value universe we ranked 1 of 210 (1st percentile).

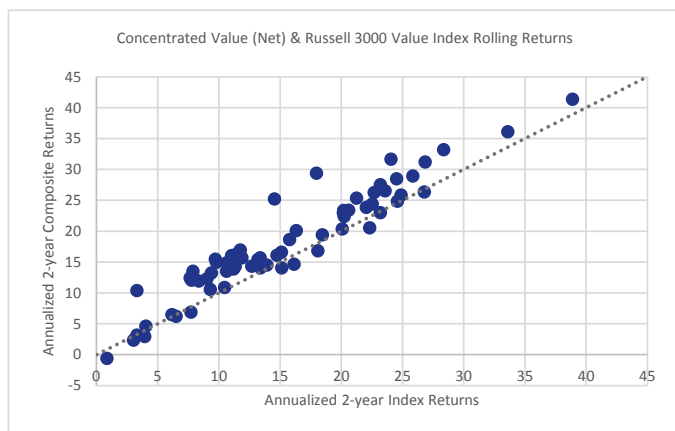

Your team at Nuance cautions clients regarding the use of short-term performance as a tool to make investment decisions. That said, if a client wants to consider our short-term performance we recommend emphasizing two-year rolling periods since our inception. Our normal discussion of short-term performance will center on two-year performance, but we will also note calendar year to date results as is our tradition.

For the period ending April 30, 2016, the Nuance Concentrated Value Composite two year rolling return is 4.6 percent (net of fees) versus the Russell 3000 Value Index 4.0 percent and the S&P 500 Index 6.9 percent. Overall, we have outperformed in 54 out of the available 66 two-year periods as shown in the chart labeled Rolling 2-Year Return Periods.

Year-to-date, the Nuance Concentrated Value Composite was 11.1 percent (net of fees) versus the Russell 3000 Value Index 3.8 percent and the S&P 500 Index 1.7 percent.



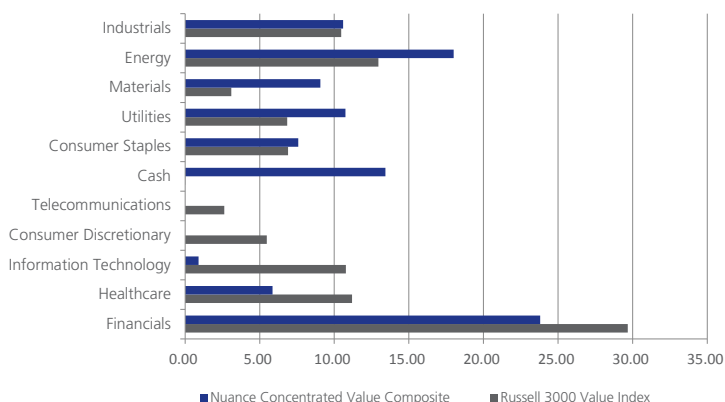

We continue to be pleased with the overall composition of the portfolio. Remember that we are seeking investment opportunities in leading business franchises with better than average valuation support. Using the table below, you can see that the portfolio has a Price to Earnings ratio of 13.1x versus the Russell 3000 Value Index of 18.5x. We are achieving this ratio with a portfolio of companies that have return on assets of 4.5% percent versus the Russell 3000 Value Index of 4.1% percent. This dichotomy of above average companies selling at below average multiples has the opportunity for outperformance over the long-term, in our opinion.

Sector Weights and Portfolio Positioning as of 4/30/2016

We have recently been adding to our weighing in the Financial sector as a retreat in interest rates has led these stocks back to attractive levels. However, we continue to be underweight the Financial sector as a whole, but this underweight positioning is driven by the Real Estate Investment Trust (REIT) industry, which appears overvalued, in our opinion. As the market rallied earlier in the year, some of our Industrial investments started to move closer to our internal view of fair value. As a result, our weighting in the Industrial sector went from overweight to more in-line with the benchmark, as we captured outperformance. The portfolio continues to be overweight Energy, Utilities, and Materials as it has been over the last several quarters. We are also underweight the Consumer Discretionary, Healthcare and Technology sectors primarily due to valuation concerns.

Stocks We Added to Your Portfolio (April 2016):

Cabot Microelectronics Corporation. (CCMP) CCMP was repurchased for your portfolio following a period of underperformance that led to what we believe is reasonable risk/reward entry point. CCMP is a leading supplier of chemical slurries used in the polishing process in the manufacturing of integrated circuit devices. With a solid balance sheet and a less cyclical profitability cycle than many technology companies, we like the entry point for CCMP.

State Street Corporation (STT): We have initiated an investment in STT following a period of underperformance that has culminated into what we consider to be an attractive risk/reward entry point. STT is one of the world's leading providers of custody, accounting and administrative functions for institutional investors and other financial asset managers. Recent concerns over low interest rates and customer related market volatility has hurt the stock and created a reasonable valuation based entry point for our clients.

Stocks We Eliminated from Your Portfolio (April 2016):

Abbot Laboratories (ABT): Following a period of outperformance we have eliminated ABT from our portfolios. We continue to like the ABT franchise and will look for better valuations to re-enter the stock for our clients.

Cameron International Corp. (CAM): Following the culmination of Schlumberger Ltd.'s (SLB) purchase of CAM, the stock is now out of the portfolio and gains have been secured. After purchasing the stock in the mid \$40's following the oil price collapse of late 2014, SLB bought CAM for stock and cash that ended up being in the mid \$60's about one year later. Clearly, CAM was a solid investment for our clients, but we would note that the buyout means we will miss being able to buy and sell CAM as a high quality energy equipment and services company for our investors over time.

Nuance Perspectives from President & CIO, Scott Moore, CFA

Year to date, your Nuance Concentrated Value portfolio is up 11.1 percent (net of fees and thru 4/30/2016). This compares to our primary benchmark, the Russell 3000 Value Index, up 3.8 percent and the S&P 500 Index up 1.7 percent. Clearly, we are pleased with the start to 2016. The primary drivers of the performance have been in the Utility and Financial sectors. Within Utilities, our holdings in National Fuel Gas Company (NFG), a stock we wrote about at length in the latter stages of 2015, has been a major contributor. Within the Finance sector our investments in BOK Financial Corp. (BOKF), Commerce Bancshares Inc. (CBSH) and Northern Trust Corp. (NTRS) have been very helpful. While I am certainly not a fan of discussing short-term performance as an indicator of much of anything, we are pleased with our year-to-date 2016 which just adds to our more important long term risk-adjusted return results.

Going forward, we continue to like stocks in the Materials sector, select Energy names and NFG as a top holding within the Utility sector. We continue to see significant overvaluation in the Consumer Staples sector, Consumer Discretionary sector, Technology sector and Real Estate Investment Trust industry.

As we remind our clients each month, your team continues to try and find leading business franchises with sustainable competitive positions that are trading below our internally derived view of fair or intrinsic value. We believe that our time tested process of finding what we view as best-of-breed businesses with better than the market downside support and better than the market upside over the long term should lead to solid risk adjusted returns versus our peers and benchmarks over time.

Compliance Statement

Nuance claims compliance with the Global Investment Performance Standards (GIPS®) and has prepared and presented this report in compliance with the GIPS® standards. Nuance has been independently verified for the periods 11/03/08 – 03/31/15 by Absolute Performance Verification. The verification reports are available upon request. Verification assesses whether (1) the firm has complied with all the composite construction requirements of the GIPS standards on a firm-wide basis and (2) the firm's policies and procedures are designed to calculate and present performance in compliance with the GIPS standards. Verification does not ensure the accuracy of any specific composite presentation. Nuance is an investment adviser registered with the Securities and Exchange Commission. The firm maintains a complete list and description of composites, which is available upon request. Results are based on fully discretionary separate accounts under management, including those accounts no longer with the firm. The U.S. Dollar is the currency used to express performance returns and assets. Performance results are presented both net and gross of management fees and include the reinvestment of income. Both gross and net of fee returns are reduced by trading expenses. Net of fee returns are reduced by Actual investment advisory fees and other expenses that may be incurred in the management of the account. The firm does not currently assess any Performance Based Fees. From the inception of each composite until 12/31/10, Time Weighted Return was compounded on a monthly basis. Beginning 01/01/11 through present, Time Weighted Return was compounded on a daily basis.

Dispersion is calculated from gross of fee returns using an asset-weighted standard deviation methodology. Only those accounts included for the full calculation period are part of the dispersion calculation. The 3-year Ex-post annualized standard deviation value is calculated using 36 consecutive monthly gross of fee returns to the end calculation period. Since Inception, Nuance has adopted the following Significant Cash Flow Policy for both composites. An account will be removed from a composite if a client has given specific instructions that prevent full investment of the cash flow(s) in a timely manner (defined as 5 business days or greater), or cumulative cash flow(s) are equal or greater than 3 percent of the total composite market value based on the end of month market value, or if cumulative cash flow(s) are equal or greater than 20 percent of the total account value based on the end of month market value. If these circumstances exist, the account will be removed from the composite and added back to the composite on the first day of the month following the date that the account is fully invested (defined as being within ten percent of the model portfolios cash target).

The Composite has been compared to various peer groups defined by investment style. The Composite is an all market capitalization value investment style. The Morningstar Large Value Peer Group, Mid Cap Value Group and the Lipper Multi-Cap Value Funds Peer Group have been presented as investment strategies with similar investment styles. For peer group comparisons all Returns, Standard Deviation and Sharpe Ratio calculations, including those of the Composite were calculated by Zephyr Style Advisor based upon strategies with monthly return data from December 2008 to 3/31/2016. Zephyr reports on month end returns only. For the purposes of peer group comparisons Since Inception returns are shown beginning 11/30/2008. The Sharpe Ratio is a calculation of a product's risk-adjusted performance over time. The Ratio is calculated by taking a product's annualized excess return over a risk-free rate (The Firm uses the Citigroup 3-Month Treasury Bill as the risk-free rate) and dividing by its annualized standard deviation calculated using monthly returns.

(2) Index statistics are provided by Russell. Characteristics calculations use holdings at market close on the stated date, including cash & cash equivalents. The following Composite characteristics are calculated using Bloomberg: Median Market Cap (midpoint of market capitalization of the stocks in the portfolio), Dividend Yield (annual dividends relative to share price), Return on Equity (net income divided by shareholder equity), Return on Assets (net income divided by average total assets). The P/E Statistics are a Nuance internal calculation. The dollar-weighted harmonic mean of individual company P/E ratios is used. This approach first considers holdings' E/P, which are then summed on a dollar-weighted basis across the entire portfolio to achieve a portfolio E/P ratio. Finally, the inverse of this ratio is taken to arrive at the Portfolio P/E ratio. Active share, as calculated by Morningstar Direct, is a statistic that measures a strategy's holdings relative to the holdings of the appropriate benchmark. Standard deviation is a measure of volatility showing the average deviations of a return series from its mean. The upside capture ratio is an indication of a manager's ability to match returns in periods of market strength, while the downside capture ratio measures a manager's ability to curtail losses in periods of index weakness. Results are gross of fees for the period since inception through present. Both upside/downside ratios and standard deviation are calculated using Style Advisor.
