Description of the Product

The Nuance Mid Cap Value Composite is a classic value investment product investing primarily in the equity or equity-linked securities of United States based companies. The product will typically maintain 50-90 positions in the securities of companies that, in the opinion of the Nuance Investments Team, have leading and sustainable market share positions, above average financial strength, and are trading at prices materially below our internally derived view of intrinsic value. The product's primary benchmark is the Russell Midcap® Value Index. Clients may also compare the product to the S&P MidCap 400 Value Index and the S&P 500 Index.

Longer Term Performance Update (through September 30, 2015)

Since Inception Return: The total return (since inception on 11/03/2008 through 9/30/2015) is 16.2 percent (annualized and net of fees) versus the Russell Mid Cap Value Index up 14.9 percent, the S&P MidCap 400 Value Index up 14.2 percent and the S&P 500 Index up 12.9 percent.

Risk-Adjusted Returns: Our Sharpe Ratio (since inception on 11/03/2008 through 9/30/2015) is 1.1 (net of fees) versus Russell Midcap Value Index at 0.9 the S&P MidCap 400 Value Index at 0.8 and the S&P 500 Index at 0.7.

Peer Group Returns through 9/30/2015: Comparing our product to peers displays positive results over time. On a total return basis, since 11/30/2008, we ranked 86th of 408 (21st percentile) peer group members in the Morningstar Mid Cap Value universe. Versus the Lipper Mid Cap Value universe we ranked 34th of 104 (33rd percentile).

Peer Group Risk-Adjusted Return through 9/30/2015: On a risk-adjusted return basis, since 11/30/2008, (as measured by the Sharpe Ratio) we ranked 2nd of 408 (1st percentile) peer group members in the Morningstar Mid Cap Value universe. Versus the Lipper Mid Cap Value universe we ranked 2nd of 104 (1st percentile) peer group members.

Your team at Nuance cautions our clients regarding the use of short-term performance as a tool to make manager or investment decisions. That said, if a client wants to consider our short-term performance we recommend emphasizing two-year rolling periods since our inception. Our normal discussion of short-term performance will center on two-year performance, but we will also note calendar year to date results as is our tradition.

For the period ending September 30, 2015, the Nuance Mid Cap Value Composite two year rolling return is up 7.8 percent (net of fees) versus the Russell Midcap Value Index up 7.2 percent, the S&P MidCap 400 Value Index up 5.2 percent, and the S&P 500 Index up 9.1 percent. Overall, we have outperformed in 41 out of the available 59 two-year periods as shown in the chart labeled Average Annual 2-Year Rolling Return.

Year-to-date, the Nuance Mid Cap Value Composite was down -2.8 percent (net of fees) versus the Russell Mid Cap Value Index down -7.7 percent, the S&P MidCap 400 Value Index down -8.7 percent, and the S&P 500 Index down -5.3 percent.



We continue to be pleased with the overall composition of the portfolio. Remember that we are seeking investment opportunities in leading business franchises with better than average valuation support. Using the table below, you can see that the portfolio has a Price to Earnings ratio of 12.3x versus the Russell Midcap Value Index of 17.6x. We are achieving this ratio with a portfolio of companies that have returns on assets of 5.9 percent versus the Russell Midcap Value Index of 3.9 percent. This dichotomy of above average companies selling at below average multiples has the opportunity for outperformance over the long-term, in our opinion.

Sector Weights and Portfolio Positioning as of 9/30/2015



Overall, our portfolio has been relatively stable from a sector weighting perspective following our weighting additions in the Energy, Finance and Industrial sectors on underperformance that occurred in the last several months of 2014 and very early in 2015. We are now clearly overweight the Energy and Industrial sectors. Our underweights include the Healthcare sector as the combination of fully valued to overvalued stocks and evolving competitive positions make it difficult to find ideas that fit our process. We are also underweight in the REIT industry as that space continues to appear fully valued or overvalued driven broadly by what we have termed the chase for yield.

Nuance Perspectives from President & CIO, Scott Moore, CFA

Through nine months of 2015 we are seeing what we believe to be a natural reaction to a broad market that has been fully to modestly overvalued combined with economic and growth uncertainties. Namely a decline in market prices. This decline is providing our team with an increased opportunity set from our group of leading business franchises. In particular, we are adding to agriculture related stocks, some industrial machinery stocks and we continue to like our positions in energy equipment and services and some banks. On a year-to-date basis, your Nuance Mid Cap Value product is now down -2.8 percent (annualized and net of fees) versus the Russell Mid Cap Value Index down -7.7 percent and the S&P 500 Index down -5.3 percent. Continued near-term concerns over slowing global economies, particularly China, coupled with concerns over the potential for the Federal Reserve to raise interests has resulted in increased volatility. As we mentioned last quarter and want to emphasize once again, near-term issues and broad economic concerns do not drive our investment decisions. Rather, our decisions are made by studying one company at a time and focusing on the true intrinsic value of each company. With that number we then allow near-term volatility, emotions, fear and greed to change the market's perceived value of the stocks in which we are invested. As our long-term view of internal intrinsic values is much more stable than current market values, we believe the increased volatility is quite helpful for us in many, if not most, instances.

As always, we want to remind our clients that we believe the longer the time horizon for reviewing a manager's performance the more appropriate. Your Nuance Mid Cap Value product is up 16.2 percent (APR and net of fees) versus the Russell Mid Cap Value Index up 14.9 percent and the S&P 500 Index up 12.9 percent since its inception on November 3, 2008. On a net of fee and non-annualized percentage rate basis, your Nuance Mid Cap Value product is up 182.4 percent versus the Russell Mid Cap Value Index up 161.0 percent and the S&P 500 Index up 131.0 percent. An emphasis on shorter-term time periods and shorter-term results is a natural emotional reaction to many things in life and appears to be a trend that is possibly growing more pervasive rather than less pervasive. We want to remind our clients that judging any investment manager over shorter term time horizons and then buying and selling their product based on those shorter term results is akin to flipping a coin which, in our opinion, is not an appropriate method to judge the results of any money manager over time.

Overall, we continue to find leading business franchises with sustainable competitive positions that are trading below our internally derived view of fair or intrinsic value. We believe our time tested process of finding best of breed businesses with better than the market downside support and better than the market upside.

Nuance claims compliance with the GIDS® standards. Nuance has been independently verified for the periods 11/03/08 – 03/31/15 by Absolute Performance Verification. The verification reports are available upon request. Verification assesses whether (1) the firm has complied with all the composite construction requirements of the GIPS standards on a firm-wide basis and (2) the firm's policies and procedures are designed to calculate and present performance in compliance with the GIPS standards. Verification does not ensure the accuracy of any specific composite presentation. Nuance is an investment adviser registered with the Securities and Exchange Commission. The firm maintains a complete list and description of composites, which is available upon request. Results are based on fully discretionary separate accounts under management, including those accounts no longer with the firm. The U.S. Dollar is the currency used to express performance returns and assets. Performance results are presented both net and gross of management fees and include the reinvestment of income. Both gross and net of fee returns are reduced by trading expenses. Net of fee returns are reduced by Actual investment advisory fees and other expenses that may be incurred in the management of the account. The firm does not currently assess any Performace Based Fees. From the inception of each composite until 12/31/10, Time Weighted Return was compounded on a daily basis.

Dispersion is calculated from gross of fee returns using an asset-weighted standard deviation methodology. Only those accounts included for the full calculation period are part of the dispersion calculation. The 3-year Ex-post annualized standard deviation value is calculated using 36 consecutive monthly gross of fee returns to the end calculation period. Since Inception, Nuance has adopted the following Significant Cash Flow Policy for both composites. An account will be removed from a composite if a client has given specific instructions that prevent full investment of the cash flow(s) in a timely manner (defined as 5 business days or greater), or cumulative cash flow(s) are equal or greater than 3 percent of the total composite market value based on the end of month market value, or if cumulative cash flow(s) are equal or greater than 10 percent of the total account will be removed from the composite and added back to the composite on the first day of the month following the date that the account is fully invested (defined as being within ten percent of the model portfolios cash target).
